Kwanlin Dün First Nation successfully registers settlement land in Yukon Land Titles Office

WHITEHORSE – Kwanlin Dün First Nation has received the first Certificate of Title for Category A Settlement Land from the Yukon Land Titles Office.

It is now possible for individuals or businesses to purchase a leasehold interest on Settlement Land and register it in the Yukon Land Titles Office. Leasehold interests may be bought and sold, and eligible purchasers can qualify for mortgages and other financing options.

A leasehold interest on Settlement Land provides certainty of exclusive possession of that land for the duration of the lease. While the First Nation remains the owner of the Settlement Land, the Yukon Land Titles Act, 2015 applies to any leasehold interest registered in the Yukon Land Titles Office.

As Kwanlin Dün First Nation begins to unlock the potential of its Final Agreement and develop Settlement Land, it will adhere to the guiding principles of the Kwanlin Dun First Nation 2017 Traditional Territory Land Vision and the Kwanlin Dun First Nation Community Lands Plan, which will be finalized in 2019.

Kwanlin Dün First Nation is the largest private landowner in the City of Whitehorse. Responsible land development – both commercial and residential – is a key to the First Nation's long-term economic sustainability.

Quick facts

In recent years, KDFN Council amended its Self-Government Agreement (2015) to ensure registered leases have priority over Aboriginal rights, interests and title for the period of the lease agreement. The Government of Yukon amended its Land Titles Act in 2016 to allow Settlement Land and leases to be registered in the Yukon Land Titles Office.

Since then, legal and financial structures have been established to allow for long-term (up to 125 year) leases that can be registered in the Land Titles Office. When a lease ends, Aboriginal rights, interests and title resume priority.

Earlier this year, Kwanlin Dün First Nation successfully registered a small piece of Settlement Land at the Land Titles Office, which enables financing to be obtained.

This winter, Kwanlin Dün First Nation citizens will be consulted about a draft Community Lands Plan, which will guide the planning and use of KDFN settlement land within the City of Whitehorse and inform the City of Whitehorse's Official Community Plan.
